## **Preface**

Research at Indian Institute of Management Bangalore (IIMB) covers all the functional areas of management. Faculty members at IIMB are involved in both theoretical and applied research with an aim to develop conceptual understanding as well as empirical study focusing on industry-specific issues.

This report provides details of research and publication activities at IIMB during the period April 2010 to March 2011. I am pleased to state that the research output including publications in academic journals, books, book chapters, case studies and editorial columns in newspapers by IIMB faculty members have significantly increased compared to the previous year. This year, IIMB faculty members have published 10 books and 78 articles in academic journals. IIMB faculty members initiated several research projects funded by both private and public sector companies.

IIMB became the first Indian institute to sign a contract to distribute case studies through Harvard Business Publishing (HBP). During the current academic year (2010–11), 12 cases along with their teaching notes were distributed through HBP. IIMB also signed an agreement with Richard Ivey School of Business to write cobranded cases, four cases and teaching notes were published by Ivey Publishing. IIMB also initiated research collaboration with the Richard Ivey School of Business, Canada and the University of Exeter, UK.

Research ambience at IIMB is enriched by seminars at which researchers from various academic institutes and research organizations share their research work. More than 40 researchers from across the globe visited IIMB and delivered research seminars that were conducted every week. Several conferences and open houses were conducted at IIMB to discuss many contemporary research themes at IIMB.

Most research publications listed in this report are in the public domain. Please contact individual authors for further details or for copies of the papers if they are not easily accessible.

#### A19 CSR Practices among Indian and UK Retailers

Project Team: Sourav Mukherji

Summary: Following an in-depth qualitative research methodology; this research

compared Corporate Social Responsibility (CSR) practices among six major retailers, three from India and three from the United Kingdom; and tried to analyse and explain the differences that were observed. CSR practices were found to be more mature in the UK than in the Indian retail industry. UK firms tended to be more open and sensitive towards CSR, appeared to be more proficient in their stakeholder relations, exhibited higher CSR transparency and structured CSR more consistently. In contrast, CSR practices by Indian retailers were in a formative stage, characterized by being unstructured, informal and sometimes, inconsistent. For example, none of the studied Indian retailers released CSR reports and only one of the retailers had dedicated personnel to drive CSR activities. These observed differences could be explained by developmental differences between the UK and Indian retail industries. Our analysis revealed that UK retailers seemed to be more interested global issues, while the studied Indian retailers focused on local issues. Overall, in the UK there seemed to be greater consciousness and more CSR activities pertaining to environmental sustainability (reduction of energy consumption and waste management) as opposed to economic well being of any disadvantaged groups, though all the companies studied had "support for communities" as one of the several objectives of their CSR initiatives. The CSR activities that we witnessed among the Indian retailers were focused more on inclusivity rather than on environmental management. This situation can be explained by the fact that environmental regulation is more prevalent in the UK than in India. This confirms observation in extant literature which suggests that CSR programmes tended to be heavily influenced by socio-economic priorities of different countries, which tend to be global issues in developed countries and the need for health care, infrastructure and education in developing countries (Blowfield and Frynas 2005; Frynas 2006).

Major results have shown that attendance, retention and achievement rates in the sample schools present a positive picture, especially with respect to girl students who have achieved higher rates of attendance and relatively lesser failure rates as compared to that of boys. Secondly overwhelming proportion of primary school teachers and all of upper primary schools have received in-service training. However, some of the recommendations are that civil works component needs to be addressed on a priority basis; school infrastructure with regard to playground, toilets and compound wall needs to be strengthened and MDM infrastructure needs strengthening.

As a response to this situation, the community monitoring exercise was introduced by the National Rural Health Mission in 2007. However, so far there is lack of clarity regarding the social processes that underlie this exercise and how the data collected from citizens and health workers can be integrated with the existing health information system. This research collaboration aims to fill this knowledge gap by putting in place a programme of research, teaching and workshops providing an opportunity for cross-fertilization of expertise and approaches between the LSE and the Indian Institute of Management, Bangalore.

A review of literature on the strategic role of IT indicates that contemporary firms need to constantly upgrade their IT capabilities and maintain flexible IT systems to support the business agility required in today's hypercompetitive environment. In this paper, we argue that OSS lends itself well to this iterative process of capability development; providing firms with a strategic advantage through reuse of OSS. We conduct a qualitative case study-based research of commercial firms to assess the strategic imperatives in reusing OSS. Results indicate that the primary motivation for reusing OSS is the ability to innovate through the reuse of open source components along with its embedded knowledge, supported by independence from vendor lock-in. Specific advantages enjoyed by firms through the use of OSS include

flexibility, interoperability, stability, security and time-to-market.

Summary: The Asian Development Bank (ADB) provided a programme loan to the

> Government of Assam in the early part of this decade to help stabilize its fragile finances. We evaluate the immediate short-term implications of this programme with a focus on own tax revenue generation and interest payments using a synthetic control method that not only allows us to take into account baseline levels of performance for Assam but also to model what would have happened in Assam in the absence of the ADB intervention. We find that the ADB programme led to an average 0.40% increase in the own tax to gross state domestic product (GSDP) ratio in the 3 post-intervention years than what would have happened in the absence of the programme. However, these gains

do not extend to the interest payments to the GSDP ratio.

Summary: The Gender and Health Equity (GHE) project is an action research project

that has been implemented in Koppal, a very backward district of Karnataka state, via a partnership among the Indian Institute of Management Bangalore, Mahila Samakhya Karnataka, and the Department of Health and Family Welfare, Government of Karnataka. The principal aim of the project has been to reduce maternal mortality in the project villages by focusing on the following specific objectives: increasing awareness, improving access, and strengthening accountability. By leveraging the partnerships forged amongst the stake-holders, the project has attempted to reach its objectives through inter-related strategies, namely, community mobilization and institution building; increasing the responsiveness of the health service providers and policy research. #### A41 Legal and Institutional Perspective on Citizen Centric Urban Governance

Summary: This research study is based on the proposition that proximity to the

governed, and their participation, is a defining feature of effective governance. With almost one-third of India's population residing in urban areas, it is imperative to explore legal, regulatory and institutional options to enable greater citizen participation in the planning and implementation of urban governance. While the 74th Amendment to the Constitution of India (in 1993) provides a common framework for the content and structure of urban local self-governance across the nation, this study is seeking to establish the pillars of accountability and autonomy on this constitutional foundation of participatory form of local governance. Accountability is in terms of the devolved powers being exercised by the urban local bodies to achieve the planned outcomes in the core functional domain. Autonomy is essential for the municipal bodies to collaborate with the private sector expertise and leverage the enormous economic synergy that is now associated with establishment and provision of urban infrastructure and public services. Specific deliverables are based on the objectives of the study, which are to: review the relevant aspects of the constitutional framework, propose the legislative support required to enable autonomous contracting by the municipal government, and suggest an agenda to enable an empowered form of participatory urban governance.

#### A42 Understanding Malnutrition in India

Summary: Slums in our cities have become a regular feature of the urban landscape;

NSSO estimates suggest that there were 52,000 slums in 2002 - notified



and otherwise across the entire country in urban areas. People of vastly different economic and social background live together in the slums with poor infrastructure and little ability to cope with economic and other shocks such as adverse health events (illness, short duration or chronic and even death). Interestingly, a number of research studies report that the correlation between incomes and staying in slums is nowhere near perfect suggesting that households who live in slums may actually be well above conventional standards of poverty as measured by urban poverty lines. The research plan is to examine the relationship between economic status, residing in a slum and health outcomes. We have begun look at multiple data sources such as the NFHS, DLHS and the IHDS to construct nationally representative estimates of costs of accessing healthcare in urban areas.

#### A43 Urban Livelihoods

Project Team: Rajalaxmi Kamath

Summary:

The current initiative was born out of a year-long study with 100 poor families in Ramanagara. Entitled the "Financial Diaries of the Poor", the study tracked the daily financial inflows and outflows of these families. Unsurprisingly, the one strong need that was expressed by a majority of the participants was that of a regular source of livelihoods. There were Muslim women among the participants who were already skilled in hand embroidery, and hence was born the idea of upgrading this skill, and marketing it. A group of women have been trained to upgrade their skills in hand embroidery. The department of women and child development, Ramanagara has sanctioned funds to train more artisans. IIMB collaborated with the Srishti School of Design to develop a range of hand embroidered accessories brand named "Minchu". Students of Srishti and IIMB helped test-market the products through sales at colleges and software firms. The initiative holds out the promise of sustaining itself thereby providing a livelihood to the artisans engaged in production since the response to the products has been encouraging. Revenues from sales helped pay wages of five artisans for a period of 2 months (ranging from Rs. 70-80/ day depending on the number of hours of work put in). Marketing efforts therefore need to be stepped up.

#### A50 Determinants of Inventory Trends in the Indian Automotive Industry: An Empirical Study

Project team: Haritha Saranga, Arnab Mukherji and Janat Shah

Inventory management has emerged as one of the important tools to improve operational efficiency over the last 30–40 years across the globe. Japanese companies such as Toyota pioneered lean manufacturing, which emphasizes on the need to maintain low inventory levels across the supply chain through practices such as JIT, Kanban, vendor-managed inventory, etc. Anecdotal evidence suggests that, inventory levels in general have been falling in the Indian manufacturing industries too in the recent past. The Japanese influence on the Indian manufacturing industry began with the entry of Suzuki into the Indian automobile industry in the mid-eighties. Since then, the principles of lean manufacturing have permeated across many industries, especially the automotive sector in India. However, there is scant empirical research in the literature that documents the inventory trends and the determining factors in India. This study aims at filling this gap through a comprehensive inventory trend analysis in the Indian automotive industry during the 14-year-period, i.e., 1992-2005 with an objective to determine the inventory trends and identify the influencing factors. We use advanced econometric models to study the impact of various factors, such as the firm's cluster, tier, export and import intensity on inventory levels. The study finds that average inventory has been steadily declining, with all three inventory components, viz., raw material, work-in-process and finished goods inventory contributing to this decline. The results suggest that the efficient working capital management and the quality improvement efforts of Tier 1 firms have been one of the major contributions to the decline in average inventory levels in the Indian auto industry.

#### A51 Value of Information in a Serial Supply Chain under a Non-stationary Demand Process

Project Team: Siddharth Mahajan and Omkar Desai

Summary:

We consider the two-level supply chain of Lee, So and Tang (2000) with a single manufacturer supplying a single retailer. The retailer faces non-stationary demand that follows an ARIMA (0,1,1) process, as opposed to an AR(1) process in Lee, So and Tang. Without information sharing in the supply chain, the retailer only conveys his order to the manufacturer. With information sharing, the retailer at the end of the period, in addition to conveying his order also conveys his demand level for the period. The use of a model of non-stationary demand becomes important, given empirical work that demand for a high percentage of SKUs at a supermarket can be autocorrelated. This is because of the repeat purchase behaviour of customers. We consider a periodic review system for both the retailer



and the manufacturer and derive expressions for the retailer's and the manufacturer's demand over their respective lead times. We also derive expressions for the manufacturer's optimal order upto level with and without information sharing. We investigate whether the reduction in manufacturer costs with information sharing increases, as the demands become more correlated over time. We would also consider the effects of a reduction in lead time from the manufacturer to the retailer, on retailer and manufacturer costs. We try to find, if a reduction in lead time reduces the retailer's costs more than the manufacturer's costs.


Urban Infrastructure and Governance




Services Integration in South Asia: Trade, Investment and Mobility Oxford University Press, New Delhi, 2011
