



Executive Post Graduate Programme in Management (EPGP) 2022-23

Admission Procedure

The Executive Post Graduate Programme in Management (EPGP) is a full time one year residential programme.

The EPGP admission process starts with the submission of the online application form.

The basic criteria for applying to the programme include

Graduation* in any discipline with a minimum of 50% marks or equivalent Cumulative Grade Point Average (CGPA). Applicants from SC ,ST and PwD categories should have a minimum of 45% or equivalent CGPA.

[*Applicant/s who have not undergone any Bachelors Degree but completed their CA/ICWA/CS after Class XII, are also eligible to apply for EPGP 2022. The requirement of minimum percentage marks /CGPA remains same as mentioned above]

- Minimum 5 years (and preferably less than 12 years) of work experience as on March 31, 2022, after completion of graduation.
- A valid GMAT or GRE score.

Please note that the IIMB EPGP code for GMAT is **Q9H-KK-84** and for GRE is **1675**. Use these codes to have your score sent directly to IIMB. Your official score report from Pearson / GMAC (for the GMAT) or ETS (for the GRE) will be used for verification.

- A Statement of Purpose (SOP) that enables the applicant to highlight his/her future goals and achievements
- Two references (on-line), preferably one from the current employer or from an individual who is in a position to evaluate the applicant's performance on the job.

Applications that are complete in all aspects and qualify in terms of the minimum academic and other criteria specified above are evaluated for being progressed to the next stage in the admission process. Shortlisted candidates will be called for the interview process.

The interview panel will evaluate each candidate's performance in terms of quality of work experience, diversity, leadership qualities, social sensitivity, and multi-facetedness.

As a general approach to selecting a candidate to the programme, a multi-factor model is used. These factors include academic track record, GMAT/GRE scores, quality of work experience, performance in the interview and writing ability test. A composite total score will be calculated for each applicant using the

multi-factor model. A merit list is prepared based on the composite total score. The offer of admission will be made to a certain percentage of applicants in the merit list. The number of offers made will depend on the availability of seats. The number of offers will be further subject to the candidate meeting a minimum cutoff in terms of the composite score and / or for any other factor score that the admissions committee may decide on.

Reservations:

The Institute will follow reservation for EWS, NC-OBC, SC, ST and PWD in accordance with the law.

Important Dates:

The IIMB Programme Marketing team and the admissions team will hold a number of Information sessions to disseminate information about EPGP and to answer questions that potential applicants may have about the programme. You may please refer to our website and register to attend.

The selection process for the EPGP 2022-23 batch will be conducted in three rounds. Candidates can submit their application during any of these three rounds. Candidates are expected to apply to only one of these three rounds. Candidates found applying in more than one round will be disqualified from further process of selection.

The documents to be submitted as part of the application process are listed below. Please ensure that all the documents submitted are complete in all respects.

- a) Documents to be uploaded :
 1. SSC, HSC & Bachelors’ Degree Transcripts
 2. Bachelor’s Degree Certificate
 3. GMAT/GRE Score Sheet
 4. Statement of Purpose for pursuing the EPGP programme

5. Work Experience letters / Payslips (First & Last) - *indicating Date of joining*
 6. SC/ST/NC-OBC/EWS Certificate (if applicable)
 7. Person with disability (PWD), then the relevant disability certificate
- b) Submission of Reference letters is mandatory. Provide details (email id & contact details) of two persons as your referees in the on-line application (*preferably one from the current employer or from an individual who is in a position to evaluate your job performance*). References will have to be submitted online by the referees directly on or before the stipulated last date for submission of application. Please inform the referees accordingly when you approach them for providing references. References are a part of the application and you will be able to submit the application only after the Reference section is complete. No separate extension will be allowed for submission of References outside the application. References cannot be received/submitted separately.
- c) The application fee is non-refundable and should be paid on-line. Details for making the online payment are provided in the application form.¹
