





# Mahatma Gandhi National Fellowship (MGNF) Programme www.iimb.ac.in/mgnf



Jointly designed by IIM Bangalore and the Ministry of Skill Development and Entrepreneurship (MSDE) in the Government of India, the Mahatma Gandhi National Fellowship (MGNF) pilot programme was initiated in March 2020 to create a cadre of individuals who would assist the district administrative structure in supporting the delivery of skill development programmes while receiving education and training at a leading management institution.


The pilot phase of the 2-year Fellowship programme is currently active with 69 Fellows posted in 69 districts of India across six states (i.e., Gujarat, Karnataka, Meghalaya, Rajasthan, Uttar Pradesh, and Uttarakhand). Based on the success of the pilot phase, the programme has been extended to 661 more districts across the country. In phase 2, IIM Bangalore is managing 79 Fellows posted in 79 districts across six states (i.e., Odisha, Karnataka, Goa, Haryana, Uttarakhand, Tripura).

Implemented in collaboration with the State Skill Development Mission (SSDM), Fellows are assigned to a district during the two years where they assist the Department of Skill Development and work toward energising the functioning of the District Skill Committee (DSC) to support the districts skill ecosystem and ensure better growth and development.

State Specific Story

As a State Resource Associate with extra responsibilities for Goa and Karnataka, I got the chance to work on the economy, livelihood, employment, skills, and entrepreneurship particular to each state in a decentralised way.

I have actively participated in the District Skill Committee meetings and collaborated with the Fellows from the districts. Many of the applicants for the job melas and apprentice melas were hired and made an effort to prevent migration from their home districts. In the states of Goa and Karnataka, we introduced numerous district-specific special initiatives carried out with the backing of the state and district administrations. All these significantly impacted the income and standard of living of the local population. These programmes helped the SHGs and FPOs by creating self-sufficient earners in the community and allowing them to earn at their local locations.

The three-party convergence with the Goa State Skill mission, Goa Road Transport, and a private organisation helped generate employment for the local heads while at their study. New skill jobs were planned and implemented in the ITIs, which is a remarkable achievement by the Fellow as it triggered a tremendous change in all areas. To encourage those districts to study at the grassroots level, the Fellows prepared and submitted their district-specific dissertations for five years to the Ministry of Skill Development and Entrepreneurship along with the State Skill Development Missions. These dissertations will be a game changer in the district economy if adopted.

Working in the Programme Management team of MGNF IIM Bangalore, Public Policy department, has been an amazing learning experience for me. I am posted in Panchkula, Haryana, as a part of this project to coordinate between Skill Development Missions and the MGN Fellows placed in the different districts of Haryana and Uttarakhand states. As a part of my job requirements, I got an opportunity to extensively travel to the districts of Haryana and Uttarakhand, and interact with various stakeholders responsible for implementing skill development initiatives including the district administration. During my visits to Ambala, Kurukshetra, Charkhi Dadri, Bhiwani, Panchkula and Rohtak districts of Haryana and Dehradun and Chamoli districts of Uttarakhand, I interacted with the officials of Rural Development and Self Employment Training Institutes, Polytechnics, Industrial Training Institutes, TATA Strive centres, Skill training centres supported by Skill Development Missions and the district officials.

## **MGNF Activities**

## **Documentary Shoot**

The Programme Management team, MGNF, successfully documented stories of success from each of the five states -- Odisha, Haryana, Tripura, Goa, and Karnataka. A team including the Programme Manager, State Resource Associate and Professor went to each state and visited the districts with good success stories and where actual changes were seen. The Fellow's contribution in the success of these cases, and their engagement and involvement in the district were documented to understand their perspective and role as a MGNF. During the visits, the team met the villagers and the other producer group members, understood the before-and-after scenario and documented their side of the story as to how MGNF had helped them in economic upliftment through better livelihoods. To see such real cases from the ground was very inspiring as the real role of MGNFs could be understood and the significance of the fellowship could be seen.





Apart from that, the team also met the District Collectors, District mentors and the reporting authorities of the Fellow to understand their expectations from the programme and how and to what extent the MGNF has been able to fulfil that. The PMT was glad to receive positive feedback from all the bureaucrats regarding the performance of the Fellows in the districts. The same documentaries were given to the communications team at IIMB for further editing and the final output was reviewed by our Programme Directors. The documentaries were published on social media platforms such as LinkedIn and also displayed during one of the meetings with MSDE at Delhi, which was very well appreciated by everyone. Other IIMs were asked to follow the same process of documenting the best success stories from their individual cohorts like the one our Programme Management team from IIMB did in a successful manner.



## **Exhibition cum Poster presentation**

An exhibition cum poster presentation was organised by the Programme Management Team, where the Fellows were told bring specific products from their districts and exhibit them during the closing ceremony of MGNF Programme. At the same time, the Fellows were also told to make posters which were themed on how MGNF had impacted the perspectives and beliefs of the Fellows and their stakeholders through them, ultimately leading to profound personal, public administrative and grassroots transitions. The purpose of the poster presentation was to allow the Fellows to reflect on their learnings and showcase the impact of the fellowship from their point of view. The posters would include region-specific information, the interventions taken up during the fellowship, the outcomes of these interventions and the learnings gained.





Additionally, the Fellows were free to exhibit any locally produced products that could be considered examples of their initiatives. SHG product exhibition and poster presentations were also held for a larger IIM Bangalore audience to witness the progress and learnings of the Fellows from the district. Fellows from each state exhibited posters containing their project highlights, initiatives and outcomes achieved during their two-year fellowship journey and discussed their important interventions with the IIMB audience. Faculty mentors including Programme Directors graced the exhibition with their presence. Students and staff who visited the exhibition enquired from the Fellows about the importance and relevance of the displayed

SHG products to the skill ecosystem of their districts.



## **Learning Workshop and Convocation**

Professor Tripthi Singh interacted with MGN Fellows in a day-long Personality Assessment Workshop through various interactive games and storytelling. The objective of these sessions was to equip MGN Fellows with necessary conflict management strategies helpful in their upcoming professional roles.

The first activity of the workshop was the Thomas-Kilmann Conflict Mode Instrument. In this session, Prof. Singh floated a questionnaire with several pairs of statements describing possible behavioural responses. She suggested that students consider and respond to situations where they find their wishes differing from those of another person. At the end of the session, she discussed the profile of scores of students which indicated the repertoire of conflict-handling skills which they as individuals used in the conflict situations they faced in everyday professional scenarios, labelled "competing", "collaborating" and so on.







Another activity was related to 'Team Roles' and understanding the relationship between team effectiveness and the team roles members play. Prof. Singh explained that the personalities of team members influenced their team's effectiveness and that individuals tend to play a role within the team, dependent upon aspects of their personality. A better understanding of team roles can lead to a greater understanding. Water Jars worksheet, Locus of Control Inventory, resource crunch game and values sheet story discussion were some of the activities conducted during this workshop. The idea behind these activities was to stress the importance of a collaborative approach and positive attitude towards work in professional spaces.









During the learning workshop, Fellows individually presented their presentations in the presence of their faculty mentors during the discussions at the New IIM Bangalore campus; some faculty mentors joined online via Zoom to interact with their mentee Fellows. The workshop assessed the understanding of the Fellows with respect to the overall economy and skilling ecosystem of their districts and their plans for the growth of economy through the key economic growth drivers supported by their involvement in planning/ supporting/ implementing initiatives in strengthening the skill ecosystem of the district during the two years of their deployment. This allowed the Fellows to present the overall picture of the district's economy and the skilling ecosystem and the feasible plans for its growth. The presentation of each Fellow covered the major components of the dissertation, followed by key takeaways from the journey of two years as the Mahatma Gandhi National Fellow. They also shared their experiences and learnings





from their engagement with the entrepreneurs, communities, SHGs, NGOs and other significant achievements and initiatives during their tenure. Fellows pre-recorded the workshop presentations and uploaded the videos on a drive. Each Fellow was allocated 15 minutes in total — nine for presentationcontaining no more than nine slides, and six for a Q&A session. The Faculty Panel mentors evaluated the Fellows' performance in the workshop and gave their valuable feedback based on detailed analysis of the districts economy and expected growth through the identified growth drivers in terms of income and employment generation, highlighting the existing skilling ecosystem with gaps and suggesting feasible plans to support the expected economic growth of the district.



## **MGNF Coordination Committee Activities**

IIM Kozhikode- Kochi campus

As the programme entered the sixth and last module in August 2023, it was important to review the progress and plan the activities for the upcoming deliverables and related requirements under the programme. The meeting was called by the MGNF Coordination Committee and hosted by IIM Kozhikode at their Kochi campus during 1 and 2 September 2023. Programme Management Teams from all member IIMs (except for IIM Ranchi) participated actively in the workshop and supported in making it successful.

The workshop began with a welcome note by Professor Venkat Rao, Programme Director-MGNF IIMK, where he expressed his valuable thoughts, motivated the participants to work collectively and frame the action plans that would guide us as we move forward. He also suggested coming up with ideas and recommendations for continuing the MGNF programme that could be further shared with MSDE in due course. The workshop was facilitated by Mr. Sreekanth Narayanan and Mr. Paritosh Pathak, Programme Managers-MGNF at IIMK & IIMB respectively.





## Meeting with Secretary MSDE, 18 September 2023

A meeting was called by the Secretary MSDE on 18 September at Kaushal Bhawan, New Delhi. The purpose of the meeting was to assess the progress of MGNF Phase 2 and plan for the convocation. The IIMB team prepared a comprehensive presentation by collecting relevant data and information from other IIMs. Professor Arnab Mukherji led the IIMs and updated participants on the progress and achievements of MGNF. Other Programme Directors also shared their experiences and opinions on various issues. The dates for the convocation were also approved by MSDE as proposed by the IIMs. The meeting was successful in the sense that all IIMs actively participated and there was uniformity across all deliverables and milestones. There was also a group photograph followed by lunch. This was also a good opportunity for programme teams of all IIMs to meet physically and share their views.

It has given me a blend of two-year academic sessions at IIM Bangalore along with intensive district immersion at the ground level in working closely with the district administration. It was a unique win-win programme where the district got a Fellow resource full of newage ideas, strategy-making, problem-solving and management skills and the Fellow got a real onground experience of two years working with the government and public sector while studying at IIM. I had the District Collector, Shri Lingraj Panda, as my mentor during the district immersion to carry out my assignments under the faculty panel mentors' guidance of Prof. Vasanthi Srinivasan and Prof. Gopal Naik from IIMB.

Public Policy and Management from IIM Bangalore equipped me with enough knowledge, skills, and confidence to excel in the field of policy development for the Government of India. The rigorous curriculum, dynamic environment, and exceptional faculty have played an instrumental role in shaping my professional growth.

## **Skill Development Impact:**

I have implemented a lot of skill development projects during my two years journey in Gajapati. I will mention my top three projects. 1) Transgenders Skill Development for Formal Local Employment & Small Business Development; 2) Agniveer Pre Recruitment Training Camp - To promote 100 youth of Gajapati for Agniveer recruitment by giving them physical and academic training in collaboration with different Govt departments; 3) Royal Gajapati - A platform for processing and marketing of Women Selfhelp-group products.

#### **Professional Growth:**
